## Policy and Criteria for Inclusion in the Registry

Each supervisor listed on the NASW-Illinois Chapter Supervisor Registry must meet the following criteria:

- Successfully complete the four-hour Fundamentals of Clinical Supervision Course provided by the NASW-Illinois Chapter. Clinical supervision courses which are provided by continuing education sponsors other than the NASW-Illinois Chapter are NOT eligible for the purposes of this registry.
- Be a licensed clinical social worker (LCSW) in good standing with IDFPR at the time of listing in the NASW-Illinois Chapter Supervisor Registry.

The registry is sorted into two categories: Supervisors who are NASW members and supervisors who are nonmembers. It is then sorted in alphabetical order by the social worker's self-listed city, then last name followed by first name.

**TIP!** While the best supervisor for you will be unique to you, we recommend using the "Control + F" function (search for a string of letters) and searching for either a supervisor in a city nearest you or by language.
